Introduction

Description

The 301R and 301RW act as an output for the 201C or the 301C. The 301R and the 301RW provides a standard 8 relays (DPDT 5A, 30 Vdc or 250 Vac resistive load) for the indirect activation of accessories. Since the relay module is an output for the controller, it can be located anywhere within the gas detection network.

The 301R is fully compatible with both the 201C and the 301C (the 301RW is compatible with only the 301CW) and offer LED indicators for each relay (visible only when housing is open).

Installation Guidelines


The following guidelines ensure that the equipment will work properly. Failure to strictly respect these guidelines will free Honeywell from any responsibility or liability in case of improper functioning:

- Make sure to locate the unit and sensing assembly(ies), if applicable, in an area easily accessible to a technician.
- Avoid any location where the unit could be subject to vibrations.
- Avoid any location close to noisy equipment.
- Avoid any location where temperature changes occur rapidly.
- Verify all the requirements and existing regulations which may affect the choice of location.

Wiring Details

301R Wiring

The wiring details diagram (below) represent the 8 DPDT relay circuit board. Wiring connexions are identical, regardless of the number of relays.




301RW Wiring

The relay module is available with optional wireless communication (301RW). Though it functions in exactly the same way and the wiring is the same as the standard relay module, there are some minor differences in the circuit board.

The DIP switch settings are identical for both circuit boards, only the position of the switch on the board is different.

Two jumpers on the 301RW circuit board allow users to define whether the unit will be used in standard Modbus communication or in Wireless communication mode.



Wiring of communication lines depends on the communication jumper positions: If the jumper is in Mod/Vul position, the communication terminal connections will be "live". If the jumper is in Wireless position, the communication terminal connections will be "dead"

System Configuration

DIP Switches

The DIP switches are used to change relay module addresses. If the relay module is connected to a 301C controller, the addresses range available begins at 81. If it is connected to a 201C, the range of addresses begins at 1 or 17.

The wireless module (Coordinator PCB) uses Modbus communication to transmit network information to the 301RW (PCB). A 301R, equipped with a wireless module, uses addresses 81 and 82 (81 is the default address) for communication between the wireless and relay modules.

Resetting Network Parameters Using the Dip Switch

Since the 301RW has no programming interface, the DIP switches can be used to change network parameters: a change of address done using the DIP switch when the unit is powered up resets network parameters to zero. This function, *which should only be used by authorized and qualified technicians*, resets network parameters to zero, allowing the 301RW to search for a controller in association mode.

ATTENTION

This function resets network parameters; when parameters are reset, identifiers may change, which renders Events and Groups programmed in the controller invalid and useless.

Note: Parameters will not be reset if the address is change when the unit is off.

LED Definitions

The unit has two externally visible LEDs:

The green LED indicates power status. When the unit is powered up and function the LED is lit, when the LED is off, the unit is off

The amber LED indicates communication status. This LED blinks to indicate communication between the relay module and the controller.

Limited Warranty

Honeywell Analytics, Inc. warrants to the original purchaser and/or ultimate customer ("Purchaser") of Vulcain products ("Product") that if any part thereof proves to be defective in material or workmanship within twelve (12) months, such defective part will be repaired or replaced, free of charge, at Honeywell Analytics' discretion if shipped prepaid to Honeywell Analytics at 4005 Matte Blvd., Unit G, Brossard, Quebec, J4Y 2P4, in a package equal to or in the original container. The Product will be returned freight prepaid and repaired or replaced if it is determined by Honeywell Analytics that the part failed due to defective materials or workmanship. The repair or replacement of any such defective part shall be Honeywell Analytics' sole and exclusive responsibility and liability under this limited warranty.

Re-Stocking Policy

The following re-stocking fees will apply when customers return products for credit:

- 15% re-stocking fee will be applied if the product is returned within
 1 month following the shipping date
- 30% re-stockingfee will be applied if the product is returned within 3 months following the shipping date

A full credit (less re-stocking fee) will only be issued if the product is in perfect working condition. (If repairs are required on the returned product, the cost of these repairs will be deducted from the credit to be issued.)

No credits will be issued beyond the three month period.
